## Notes:

In scope is the end-user view of online surveys. Two scenarios with fictitious questions and also different question types were evaluated for this Accessibility Conformance Report. Also in scope is the HTML report for results of evaluations done with evasys. The backend of the evasys software that was used to create these online surveys was not evaluated and is not in scope of this Accessibility Conformance Report.

The Conformance Claim covers two templates for two scenarios each including a set of different question types. Both includes simple question types like simple forms with input fields, check boxes and radio buttons as well as complex forms with radio button lists and pole graphics. Creators of online surveys are free to use the Design template or the Classic template of evasys version 8.2.

In scope of this Conformance Claim is the support of Firefox with JAWS and NVDA and the support of Chrome with JAWS and NVDA. The Conformance Claim covers also the HTML report, which provides a table view and a diagram view of the surveys result. Both views have been created with accessibility and conformance in mind. Users may switch between both views and are encouraged to do so, for example blind users and users with severe visual impairments. In some rare cases the table view functions also as an alternative version in the sense of the first conformance requirement of WCAG 2x but the majority of the success criteria have been supported in both views. Cases where the concept of alternative version plays a role for conformance are described in the explanations.

Not in scope is the documentation for creators of online surveys. Also, not in scope at the current time is the PDF report. This Accessibility Conformance Report does not cover conformance of the authoring tool (in which customers are creating online surveys) according to ATAG 2.0. Nevertheless, evasys provides additional advices and guidance for survey creators in the light of ATAG 2.0 Part B, beyond the generation of conforming online templates. Part of additional advices and guidances is a mechanism which disables a wcag-logotype for known cases which leads or could lead to a violation of WCAG 2.1 AA. Those cases together with brief instructions for accessible online surveys are listed in the documentation.

## Evaluation Methods Used:

The Conformance of the above mentioned two scenarios and the HTML report has been evaluated by manual testing and semi-automated checks.

Manual testing included keyboard testing (with and without Screen Reader), NVDA and JAWS Screen Reader, tested on Windows 10 by using the latest version of Firefox as well as the latest version of Chrome.

Semi-automated checks have been carried out by using Firefox Developer Tools, Web Developer Toolbar (Firefox), Chrome Developer Tools, Color Contrast Analyser and Bookmarklets for different purposes like simulating text spacing (WCAG 2.1). In addition, for WCAG 2.0 AA a user testing with NVDA in combination with Firefox and JAWS has been done.

For providing a more usable navigation – especially quick navigation based upon heading levels - for screen reader user H-elements instead of caption- elements have been used. Sub parts have invisible headings for screen reader user to inform about the relationships and sections and to improve quick navigation especially when users are filtering or comparing results.
